2014 IDAHO LEGISLATURE: The 2nd Session of the 62nd Annual Idaho Legislature adjourned on March 20th taking a total of 74 days to complete the business of the state of Idaho. This was the shortest session in recent history, beating the 2013 session by 14 days. The legislature saw a total of 1,107 pieces of legislation and amendments prepared, which is also a lesser number than in recent years. Only 357 pieces of legislation successfully passed the dual House system in Idaho. The 2015 Idaho Legislature will begin on Monday, January 12.

NEW LEGISLATION IN 2014 SESSION: A bill was introduced and passed during the 2014 legislative session exempting beehives brought into the state for temporary indoor winter storage from registration fees. Those who currently store hives have to register them with the Idaho State Department of Agriculture (ISDA) and pay a fee of \$10 for the first 50 colonies and subsequent to that, 16 cents a colony. Producers would still be required to register the hives with ISDA, but will not have to pay the registration fee, which varies depending on how many hives they have. Some producers connect with beekeepers from other states and temporarily store hives indoors during the winter. A small number of the hives are even stored in eastern Idaho potato cellars and will make their way to California to pollinate that state's almond crop.

The completed legislation was encouraged by the Idaho Honey Industry Association members during the group's annual meeting in December. This legislation allows ISDA to know where hives are in the state and to act quickly to address any disease issues. This bill will impact only hives brought in to the state temporarily for winter indoor storage. The bill was signed into law by the Governor on March 11 and will become effective on July 1, 2014.

CHANGE IN SCHEDULE FOR THE 2014 ANNUAL CONVENTION: The IHIA board of directors has moved the annual IHIA Banquet and Auction from Friday night of the annual convention to Thursday night. This will allow attendees to leave Boise after the last speaker on Friday. The dates of the 2014 annual IHIA convention are: Thursday, December 4 (all day with banquet that evening) and Friday, December 5 till noon.
